100% of EHA's high school graduates have been accepted into four-year colleges and universities every year. EHA is fully accredited by the Association of Christian Schools International (ACSI) and the Southern Association of Colleges and Schools (SACS). During the school year 2016-2017, EHA provided 125 Richmond children a safe,academically challenging, quality education that is value based. Considering the source of our student population, only about 16% of our income comes from tuition payments. For the balance of our funding needs, EHA House relies on donations from those who support our mission including individual donors, church & corporate sponsors, and charitble foundations. EHA recently won the Chick-fil-A Foundation True Inspiration Award & grant-Atlantic Region.
