During the school year 2022-2023, EHA provided 183 Richmond children a safe, academically challenging, quality education that is value based. Only about 10% of our income comes from tuition payments. For the balance of our funding needs, EHA House relies on donations from those who support our mission including individual donors, church & corporate sponsors, and charitable foundations.
